**Dr. Phillips** provided similar, stating that the intent of reiki involves manipulation of the soft tissues of the human body.

**Action Taken:** After discussion, Mr. Brooks moved to bring a draft order in response to the petition for review by the Board at a future meeting. Motion seconded by Ms. Drago, which carried unanimously.
